Dear Friends,

In 1978, China adopted the policy to reform and open up herself to the world, an important and historical decision that shaped the nation today. After 40 years, China has lifted almost 800 million people out of poverty and is now the world's second largest economy with an GDP that has grown from US\$218 billion to over US\$12 trillion. This path of continuous reform and opening up is ascertained by President Xi Jinping. Hong Kong has played a significant role since the beginning of the opening up and is continuing to leverage its strengths in offering the country's need such as capital, talent, management expertise and international connections. The opening up of our country not only benefits our own development but also becomes an important driving force for the growth of the world economy. Despite rising protectionism, the first China International Import Expoheld in November demonstrated the country's commitment to continue promoting free trade and share prosperity with counterparts.

Conference on "China's 40 Years of Reform and Opening up: Implications for the World and Role of Hong Kong

The recent trade conflict between the world's two largest economies clouds the global economic outlook. It is foreseen that the disputes will continue for an as yet uncertain period of time. Brexit, immigration issue and budget debate in Europe, the rise of populism and technology disruption also cause uncertainty. Hong Kong is cautious of its exposure to international volatility, and will take measures to tackle challenges and uncertainties ahead. Despite the unstable international environment, the launch of the Guangzhou-Shenzhen-Hong Kong Express Rail Link and the Hong Kong-Zhuhai-Macau Bridge in September and

> October respectively offered us better connection with Mainland cities and thus provides greater opportunities for companies and people in Hong Kong and in the region to explore and develop their businesses and careers beyond the border. With a population of 68 million and GDP amounting to US\$1,400 billion, the Greater Bay Area (GBA) is expected to create business opportunities across all sectors, particularly in finance, high-tech, innovation,

and high-end services industries. Under the Arrangement with the National Development & Reform Commission last year, Hong Kong's participation in and contribution to the Belt & Road Initiative (BRI), covering six key areas such as financial and investment, infrastructure and maritime services, economic and trade facilitation, dispute resolution services would definitely be advanced.

The year 2019 marks the 70th anniversary of the founding of the People's Republic of China. It is a time to celebrate the achievements and stability that China has made through these years and from a history of chaos. We hope that Hong Kong could serve the role of telling the story of Hong Kong and the story of China, to clear up misunderstanding and to promote international collaboration. The fallacy of the "China Threat" will not stand. The Better Hong Kong Foundation ("the Foundation") has spared no effort in reaching out to the international community to share our firsthand information and observation about China and Hong Kong for more than 23 years since its inception. We believe that communications and understanding are the cornerstones to building a better world for now and in the future.

Facilitate Communications and Way Forward

The Foundation regularly visits and updates our counterparts overseas. On 6 July, the U.S. implemented the first China-specific tariffs and the second round of tariffs was under review. The Foundation led its annual delegation to the US on 9 July. It was led by the Executive Committee Chairman Mr. Ronnie Chan, visiting Washington D.C. and New York. The Delegation not only shared our views and concerns with the U.S. interlocutors in a timely manner but was also able to gauge their thoughts and the local ambiance over the trade conflict. In late September, the Foundation organized the first delegation to Russia, a prime BRI investment destination. Also led by Mr. Ronnie Chan, Trustee Tan Sri Dato' David Chiu and Ms Pansy Ho and fourteen Council members participated in the delegation. The Delegation visited Moscow and St. Petersburg. Besides meeting local senior government officials and business leaders exploring investment opportunities and understanding economic development, the delegates were able to enjoy the beautiful scenery of the country. Friendships were forged and collaborations are in the pipeline.



The China-U.S. Journalists Exchange

In September, the Foundation organized the 9th China-U.S. Journalists Exchange program together with All-China Journalists Association and the East-West Centre. American journalists met with economists and experts from national research institutes and government officials in Beijing amidst the heating up of trade relations between the two countries. They also visited four Mainland cities in the GBA for a glimpse of developments in the region especially on innovation and technology. Hopefully, the exchange program could help the journalists have some idea about today's China.



The Foundation's Delegation to the Russian Federation Initiated and organized by the Foundation, a plenary session entitled "One Belt, One Road" was held at the World Policy Conference in Rabat, Morocco in October. The Foundation invited three prominent speakers including Mr. C Y Leung, Vice Chairman of CPPCC and former Chief Executive of the HKSAR, Mr. Shiv Vikram Khemka, Vice Chairman of SUN Group, and Dr. Bayu Krisnamurthi, former Vice Minister of Trade of Indonesia, to explain what the BRI is about and to clarify some people's concerns, in the hope that BRI could really achieve the goal of win-win for everyone participating. The session was moderated by Mr. Ronnie Chan.

Throughout the year, the Foundation hosted luncheons, inviting Chinese Ambassadors from overseas to speak, such as Ambassador to France and Monaco Mr. Zhai Jun. Ambassador to Austria Mr. Li Xiaosi and Consul General of Dusseldorf in Germany Mr. Feng Haiyang. We were also honored to host Mrs. Carrie Lam, the Chief Executive of the HKSAR, Mr. Wang Zhimin, Director of the Liaison Office of the Central People's Government in the HKSAR, and Mr. Xie Feng, Commissioner of the China's Ministry of Foreign Affairs in the HKSAR etc. On the international front, we had the chance to hold discussion sessions with a financial policy maker from Indonesia, staffers from U.S. Congress, parliament members from EU and France as well as founder of a French think tank. The discussions were enlightening and inspiring.

Reform and Opening Up To a New Era

To celebrate the 40th anniversary of the country's reform and opening-up, the Foundation in collaboration with the Commissioner Office of the Ministry of Foreign Affairs of PRC in HKSAR ("the Commissioner Office") organized an international conference in Hong Kong in October featuring prominent political and opinion leaders from the Mainland, Hong Kong and abroad. The Former Prime Minister of France, former Prime Minister of Japan, former Foreign Minister of China and former U.S. Trade Representative shared their insights regarding the implications of China's reform and opening up for the world. Over 300 audience members were in attendance at the conference. Local government officials, renowned scholars and business leaders also shared their vision over the future. The Foundation also organized another conference on the same subject with Shanghai Academy of Social Science and Shanghai CPPCC in Shanghai in November, which reviewed the path of Shanghai and China to success during the reform, the role of Hong Kong during the period and the way forward.

To keep abreast of the fast developing world, no one can be spared the effort in upgrading itself. Hong Kong will take the advantage of its unique position of "one Country, two systems" and will actively participate, contribute and excel under

the visionary national strategic plan of the development of GBA. It is also what was suggested in this year's China Urban Competitiveness Report published annually by the Chinese Academy of Social Science with the support of the Foundation. Additionally, Hong Kong should embrace the BRI and to strive to be the strategic node and hub in the region. Hong Kong people, especially the younger generation, should equip themselves with better knowledge and understanding on the Mainland c ong Education Bureau co-organized the Hong Kong Cup Diplomatic Knowledge Contest for the 12 consecutive years. Primary and secondary students were invited to participate in the contest and were encouraged to understand our country and the world by learning through their foreign policies. Students who won the contest joined a study tour to Beijing and Tianjin in July. The visit to Xiongan New Area was

an eye-opening experience to the students who were impressed by the new town planning concept with green, innovative and hi-tech elements.





2018 China-U.S. Journalist Exchange

In an effort to enhance the understanding of China and Hong Kong by the American media, since 1996 the Foundation has invited six to eight American journalists each year to visit the Mainland China and Hong Kong. The Foundation sponsored and organized their trip. With the support of the Ministry of Foreign Affairs of the PRC, the program enables the journalists to meet with senior government officials in Beijing and local municipal officials in one of the second or third tier cities in China. The Foundation also organizes meetings with key industry and business players, academic and research institutions and media practitioners to broaden the participants' network other than providing them an overview of the cities they visited. This year, the Foundation, in association with the All-China Journalists Association (ACJA) and the East-West Center, organized the 9th China-U.S. Journalists Exchange program, as an expansion of the original Hong Kong Journalism Fellows program by adding the visit of the Chinese journalists to the U.S. The theme of this year's program is "Business and Trade: Opportunities and Challenges".

A delegation of six senior U.S. journalists visited Beijing, Guangzhou, Zhuhai, Dongguan, Shenzhen and Hong Kong from 8 - 19 September 2018 while three Chinese journalists visited New York and Washington D.C. in the U.S. during the period. After their respective study tours, all Chinese and American journalists met in Washington D.C. to report on their experiences and to exchange opinions on how media coverage of each country can be improved. Through direct dialogue with local authorities and communities in different areas and seeing the developments for themselves, the U.S. journalists gain a better understanding of the current situation and future development of Hong Kong and Mainland China.



The 2018 China Urban Competitiveness Report (Hong Kong) press conference was held in Hong Kong on 29 June 2018. It was organized by the Better Hong Kong Foundation and co-organized by Center for City and Competitiveness of the Chinese Academy of Social Sciences and Hong Kong Institute of Asia-Pacific Studies of the Chinese University of Hong Kong. Led by Prof. Ni Pengfei of the Chinese Academy of Social Sciences, the theme of the 2018 Report is "40 Years: Formation of Cities Across the Country", revealing the contributions of cities in China's openingup and reforms. It also revealed the mechanism of successful development of Chinese cities in the past four decades. The press conference was chaired by the Foundation's Executive Director Ms. Karen Tan. Prof. Ni gave a presentation on the report and explained the overall competitiveness of Hong Kong. Prof. Shen Jianfa from the Chinese University of Hong Kong commented on the findings about Hong Kong.

According to the Comprehensive Economic Competitiveness Index in 2017, the top ten cities are Shenzhen, Hong Kong, Shanghai, Taipei, Guangzhou, Beijing, Tianjin, Suzhou, Nanjing and Wuhan. They are all located in the Pearl River Delta (PRD), Yangtze River Delta (YRD), Bohai Rim; and Hong Kong, Macao and Taiwan area, except Wuhan, which is in central China. This reflects the advantages of coastal areas in development. Hong Kong tops the Livability Competitiveness Index. Hong Kong ranks high in quality education, good medical environment, green and ecological environment, and active economic environment. These contribute to the top ranking of the city. Hong Kong leads in Sustainable Competitiveness Index. Hong Kong's economy maintains a good momentum of development in recent years. However, from a structural point of view, Hong Kong still faces major challenges in

terms of technology innovation, industrial diversification and upgrading. In terms of spatial development, Hong Kong should embrace the Belt & Road Initiative (BRI) and undertake the roles of strategic node and core hub in the BRI. At the same time, Hong Kong should actively participate in the formation and development of the Guangzhou-Hong Kong-Macao Bay Area (GBA). Hong Kong should make good use of its advantages and grasp opportunities arising from science & innovation, the BRI and the GBA, in order to achieve sustainable development and strengthen its urban competitiveness.

The 12th Hong Kong Cup Diplomatic Knowledge Contest

Since 2007, the Foundation has jointly organized the Hong Kong Cup Diplomatic Knowledge Contest with the Office of Commissioner of the PRC's Ministry of Foreign Affairs in the HKSAR (Commissioner's Office) and the Education Bureau of the HKSAR Government. The contest aimed to raise students' interest in international affairs and knowledge of the nation's foreign policy. The theme of the 12th Hong Kong Cup Diplomatic Knowledge Competition was "China and the World: 40 Years of Opening Up". More than 22,000 students from 125 primary and secondary schools enrolled in this year's contest which set the highest record since the launch of the contest.



The Final was successfully held on 19 May 2018

On 19 May 2018, ten shortlisted teams entered into the Final and competed under two groups, namely Elite Group and Pioneer Group, after the first-round competition in March. This year, the organizers were honored to have invited the Chief Executive Mrs. Carrie Lam as the Guest of Honor of the Final and to address us at the prize presentation ceremony. In the Final, students competed for their knowledge of foreign diplomatic affairs of the PRC, Hong Kong-related foreign affairs, national and international affairs, international relationships and diplomatic etiquette. After rounds of fierce competition, the championship in Elite Group and Pioneer Group went to Ying Wa College and Sing Yin Secondary School respectively. The Final took place at the TVB studio. More than 400 audience members, comprising of students and teachers from primary and secondary schools, were amazed by the excellent performances of the finalists. A television program about the contest was produced and broadcast on 26 May 2018.

Around 400 young people from Hong Kong, the Mainland China and overseas countries participated in the summit.
