## MESSAGE FROM THE DIRECTOR

Dear Friends,

The world is in flux. It is filled with heat as global warming is haunting us, warned by the young lady Greta Thunberg, representing the concerns of Generation Z. It is also full of anger and frustration, signified by social unrest across the continents. Nor is a prosperous and peaceful city like Hong Kong spared from such disturbances. Populism and political polarization is the norm in many countries. In geopolitics, bilateral relationships replace multilateral relationships. Artificial Intelligence and technological innovation is causing and will cause more disruption in different aspects. With this backdrop, we are leading towards a new decade of uncertainty.

In 2019, China celebrated its 70th anniversary of the founding of the People's Republic of China and is determined to stay on the path of peaceful development and continue the opening-up policy. Its success is not just rising as the number-two economy in the world, but more on eradicating absolute poverty and on creating balanced economic growth and social justice within the country.

However, the trade-conflict between China and the U.S., in fact interpreted as rivalry on all fronts, is hindering the economic growth of both countries and is disrupting the globe as a whole. Though a "phase one trade deal" was signed in January 2020, people are cautious of what could be the next move of these two giants. Brexit is now more certain to be completed. And after the U.K.'s exit from the EU, will the body continue to operate as before? Instability in the Middle-East adds to the worry of global disorder.

Despite the disturbances, Hong Kong's fundamentals and strength remains. Hong Kong is ranked world no. 1 for its financial system (World Economic Forum: Global Competitiveness Report 2019), the world's freest economy (Heritage Foundation), and tops the global IPO market in 2019. It is also ranked as Asia's no. 2 and world no. 8 for judicial independence (World Economic Forum: Global Competitiveness

Report 2019); Asia's no. 2 and world no. 11 for rule of law (The World Bank Group: Worldwide Governance Indicators); world no. 3 for human freedom (Cato Institute, Fraser Institute, and Liberales Institute of the Friedrich Naumann Foundation for Freedom: The Human Freedom Index 2018).

Opportunities are open for those who look for it and work on it. Subsequent to the promulgation of "Outline Development Plan for the Greater Bay Area (GBA)" on 18 February 2019, in March the Chinese Government introduced the eight policy measures for taking forward the development of the GBA. These measures facilitated Hong Kong residents to develop, work and reside in the Mainland cities of the GBA, as well as strengthened the flow of people and goods within the GBA. In November, another sixteen policy measures were promulgated which would further benefit Hong Kong people and facilitated the development of various sectors in the GBA. The GBA is a vibrant city cluster that collectively represents a vibrant economic force of over 71 million people, with a GDP of more than US\$1.6 trillion. We are hopeful that Hong Kong will continue to excel with its core competence under "one country, two systems", enjoying the dual advantages of being part of China, while maintaining its global outlook and institutional advantages.

## Strengthen Communication and Build New Connection

The Better Hong Kong Foundation ("the Foundation") spares no effort to strengthen communication with our counterparts as well as to build new connections. In August, led by the Executive Committee Chairman Mr. Ronnie Chan, the Foundation organized the first delegation to Beijing with Trustee Tan Sri David Chiu and 15 Council members participating. The delegation met with senior officials from the Central Government and renowned experts in economic, technology and media fields. Members could have a better understanding on the national policy towards Hong Kong while our views on the role of Hong Kong and its development were shared. Riding on the success of the delegation to Russia last year, the Foundation organized a delegation to Turkey, another significant location under the Belt & Road Initiative, in September. Led by Mr. Ronnie Chan, with the participation of 14 Council members, the delegation visited Istanbul and Ankara. The trip enriched the delegates' knowledge of Turkey's economic and social development as well as investment opportunities. A solid foundation and friendship was built under the auspicious hospitality we received from our Turkish counterparts.

In October, the Foundation initiated a plenary session entitled "Sustaining Globalization – the Chinese Position" at the 12th World Policy Conference in Marrakesh, Morocco.

It was moderated by the Foundation's Executive Committee Chairman Mr. Ronnie Chan, and Mr. Leung Chun-ying, Vice Chairman of Chinese People's Political Consultative Conference ("CPPCC") and former Chief Executive of the HKSAR was one of the speakers at the session. We hope that people could understand better China's policy of peaceful development and its role in sustaining globalization. The Foundation also supported the International Forum on the Guangdong-Hong Kong-Macao Greater Bay Area in October, jointly organized by the HKSAR Government and the Office of the Commissioner of the Ministry of Foreign Affairs ("the Commissioner's Office"). Prominent speakers from local, mainland China and overseas gathered and

exchanged views on building a platform for win-win cooperation.

The Foundation encourages views exchanges and experience sharing. In the past years, we have received many overseas visitors to Hong Kong. It is especially important in the past few months, for visitors to see and to hear in Hong Kong and from people from different parts of the society, to gain a more comprehensive understanding of the situation. The Foundation received former U.S. Senator Mark Kirk, staffers from the U.S. Congress, a group of Jewish American leaders and the President of a Polish think tank. In November, the Foundation hosted a luncheon for China's Ambassador to Belgium Mr. Cao Zhongming and Ambassador to Vietnam Mr. Xiong Bo during their visit to Hong Kong. The Foundation's members were able to learn more about the two countries' social and economic development as well as investment environment from the Ambassadors. In Hong Kong, we were honored to have discussion with senior officials including Mr. Tung Chee-hwa, Vice Chairman of CPPCC and first Chief Executive of the HKSAR, Mr. Paul Chan, Financial Secretary and Mr. Edward Yau, Secretary for Commerce and Economic on Hong Kong's future development.

## Broaden Horizon and Embrace New Opportunities

The 13th Hong Kong Cup Diplomatic Knowledge Contest that the Foundation coorganized with the Commissioner's Office and the Hong Kong Education Bureau was successfully concluded in May. The contest was organized in the hope of equipping our youngsters with knowledge of international affairs and China's foreign policy, to broaden their global vision and perspective. It is encouraging for Hong Kong people to learn of the recent appointment of five young Hong Kong civil servants, under the recommendation of the Central Government, taking up positions in the United Nations ("UN") for two years. The UN posting is a breakthrough and an invaluable opportunity for our young people to show their talents in the international arena

This year's China Urban Competitiveness Report, published annually by the Chinese Academy of Social Science with the support of the Foundation, reinforced the importance of Hong Kong to deepening economic and social integration with the Mainland, particularly the GBA, for the sake of enhancing the overall competitiveness of our city. Beside the GBA, there are also great opportunities for Hong Kong and Shanghai to work together

under the country's reform and opening-up policy. Jointly organized by the Foundation, Shanghai Academy of Social Science and Shanghai CPPCC for fifteen consecutive years, the Shanghai Forum this year invited experts from Hong Kong and Shanghai to conduct in-depth discussions on three key areas for cooperation, namely maritime and aviation, financial services and property development.





## SUSTAINABLE DEVELOPMENT OF HONG KONG

With globalization, rapid change and worldwide competition, we cannot be complacent regarding the current state of affairs. The Foundation, in collaboration with renowned research institutes, conducts studies on the competitiveness of urban cities in China as well as bench marking world cities in the pursuit of excellence. We also recognize the importance of Hong Kong's youth development and the cultivation of a green environment and corporate social responsibility for the betterment and sustainable development of Hong Kong.

## 2019 China Urban Competitiveness Report

The Center for City and Competitiveness of the Chinese Academy of Social Sciences ("the Center") announced the 2019 China Urban Competitiveness Report on 24 June 2019 in Beijing. Led by Prof. Ni Pengfei of the Center, the theme of the 2019 report is "Housing: The Impacts on Economy and Society". This year's report elaborates the effect of housing development on fostering economic growth and structural changes, preventing economic risks, and benefiting people's livelihood in China. The report also estimates the general direction of housing development and provides relevant recommendations. On 25 June 2019, the Foundation hosted a discussion luncheon where Prof. Ni was invited to give a presentation on the report and explained the overall competitiveness of Hong Kong. Supported by Hong Kong Institute of Asia-Pacific Studies of the Chinese University of Hong Kong, Prof. Shen Jianfa also attended the luncheon and commented on the findings about Hong Kong.

Hong Kong is ranked second in the Comprehensive Economic Competitiveness Index. Although the ranking of overall incremental competitiveness sub-index drops, the city's hardware and software support the good performance in the overall efficiency competitiveness subindex. Hong Kong leads in the Sustainable Competitiveness Index. Hong Kong is strong in the cultural, ecological and infocity sub-indices and tops the Livability Competitiveness Index. The high quality educational environment and ecological environment. active and economic environment are major contributing factors. Hong Kong also tops the Business-friendly Competitiveness Index. Favourable local

factors, soft environment and international connections, such as low tax base, high economic freedom and transparent legal system contribute to Hong Kong's overall business-friendly environment.

The report makes suggestions on the future development of Hong Kong in two aspects. First, Hong Kong must continue to establish the core function of "innovation + technology". This is a way to strengthen the industries with traditional advantages, and can foster the development of Al, biomedical, advanced manufacturing and cultural & creative industries. Second, Hong Kong needs to strive to be the dragonhead of the Guangdong-Hong Kong-Macao Greater Bay Area. By deepening economic integration with the Mainland, particularly the GBA, Hong Kong can be a principal

participant, promotor and beneficiary in the GBA development.

## The 13th Hong Kong Cup Diplomatic Knowledge Contest
