

MESSAGE FROM THE DIRECTOR

Dear Friends,

2017 marks the 20th anniversary of the establishment of the Hong Kong Special Administrative Region. Of note, Mrs. Carrie Lam was sworn in as the fifth-term Chief Executive in the presence of President Xi Jinping, who made his first visit to Hong Kong as national leader in this special and memorable occasion. Hong Kong has thrived with the successful implementation of “One Country, Two Systems” under the Basic Law. After the launch of Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect, the launch of Bond Connect this year further enhances the mutual capital market access between mainland China and Hong Kong, and reinforces Hong Kong’s position as the financial center of China and strengthen its position around the world.

The infrastructure connectivity provided by the “Hong Kong-Zhuhai-Macau Bridge” and “Guangzhou-Shenzhen-Hong Kong Express Rail Link”, to be completed in 2018, will afford Hong Kong much greater opportunity under

the “Guangdong-Hong Kong-Macao Bay Area” development plan which sets a new horizon for the region to transform into a world class cluster for technology and business. Together with the mega initiative of “One Belt One Road” (“OBOR”), and its membership of the Asian Infrastructure Investment Bank (“AIIB”), Hong Kong continues to offer incredible potential by further developing its world’s leading position in offshore RMB business, and as a center of fund raising and investment in mega infrastructure projects.

However, unsettling international developments have cast a shadow of uncertainty that has affected our global community. The mindset of many leaders has refocused towards the more conservative, be it on trade or human capital flow or international collaboration. Populism clouds decisions and black swans happen not just once. I hope that people will regain their rationalism and leaders adopt a spirit of openness and the principle of “pursuing shared growth through consultation and collaboration”, as suggested by President Xi, will prevail.

Lightning-speed of development in technology, artificial intelligence and Internet of things are regarded by many as a “disruption” though many are turning these forms of technology into infinite opportunity. The way how we understand the trend, rejecting or embracing, managing or being manipulated, will shape the future landscape of the world. I hope that more wise men will use it in a positive way: make it productive and for the betterment and well being of everyone, narrow societal and country wealth and resource disparity with an eye to creating harmonious communities and a peaceful world.

Pursuit for Understanding and Trust

It is therefore of utmost importance to cultivate understanding and trust with more dialogue and exchange. The Better Hong Kong Foundation (“the Foundation”) regularly organizes delegations, exchange programs and luncheon talks to facilitate the exchange of ideas and better understanding and hopefully more collaboration. In July of this year, the Foundation continued its annual delegation to the U.S., which was led by Executive Committee Chairman Mr. Ronnie Chan. Other than understanding the change under the new administration in the U.S., the delegation also shared Hong Kong’s success stories and challenges after its return to the motherland. Towards the end of summer, the Foundation organized the 8th China-U.S. Journalists Exchange program with our partners All-China Journalists Association and the East-West Centre. American journalists were able to meet government officials, academics, students, business sector representatives and to experience in person the developments of the country by visiting Beijing and Xi’an. They also got a first-hand look at how fast the digital economy is blossoming in the country. Meetings with AIB and China Institute of International Studies definitely helped the journalists to understand better the “OBOR” initiatives and the timely subject on North Korea.



The Foundation’s Delegation to the United States

During the year, the Foundation was honored to host luncheon talks for Chinese Ambassadors, including Ambassador to Argentina Mr. Yang Wanming, Ambassador to the Czech Republic Ms. Ma Keqing, Ambassador to India Mr. Luo Zhaohui and Ambassador to Italy and San Marino Mr. Li Ruiyu. We were grateful for the valuable opportunities to be shared with their wisdom on building strategic relationship with different countries and the business opportunities in their respective regions. The talk given by Dr. Zhu Min, who returned to Beijing as the Chairman of National Institute of Finance Research at Tsinghua University after completion of his term as Deputy Managing Director at the International Monetary Fund, enlightened us with his observation on the role of China under the backdrop of global economic development. The Foundation hopes that we could make use of this platform to share thoughts of leaders in different fields and to build up mutual trust and collaboration.



The China-U.S. Journalists Exchange

Engagement in National Development

After 40 years of reform and opening-up, China is now the second largest economy in the world and has been the largest contributor to world growth since the global financial crisis of 2008. While countries around the world are looking for new areas of growth, seeking collaboration with China is definitely their destination. Hong Kong, as part of China and under the advantages of “Two Systems”, is in a preferential position to play a role and to contribute

in the national development and to continue to be the “super-connector”, bridging China and the world. The Foundation always works with our Mainland counterparts to explore further collaborations and enhance synergy. Every year the Foundation, Shanghai Academy of Social Science and Shanghai CPPCC jointly organizes the Shanghai conference. This year, the Conference drew more than a hundred experts, sharing views on how we could work together on the “OBOR” initiatives. Also, the Foundation works with the Chinese Academy of Social Science on the annual report on China Urban Competitiveness Report, which provides useful analysis and recommendations to Hong Kong and other cities in China on areas of excellence and areas for improvement.

In Hong Kong, the Foundation has invited two Vice Chairmen of the Chinese People’s Political Consultative Conference and former Chief Executives of the HKSAR Mr. Tung Chee-hwa and Mr. Leung Chun-ying; as well as Mr. Zhang Xiaoming, the then Director of the Liaison Office of the Central People’s Government in the HKSAR, to share with us their insights on the country’s latest development and on Hong Kong’s roles in the grand plan, and how Hong Kong could contribute and be engaged in the national development.

The Foundation encourages our young people to understand more about their country with a global perspective. The Hong Kong Cup Diplomatic Knowledge Contest that the Foundation co-organized with the Office of Commissioner of the Ministry of Foreign Affairs in the HKSAR and the Hong Kong Education Bureau is a way to broaden primary and secondary students’ knowledge in international affairs

and foreign policies of our country. A study tour to Beijing and Yunnan was organized for the winning teams this year. Participants were particularly moved by the sharing of a few young doctors in the Chinese Center for Disease Control and Prevention who risked their lives to participate in medical humanitarian mission overseas. When they visited the HIT Robot Group, students were impressed by the advancement in innovation and technology applied in various types of robots. We hope that our younger generation could open their mind to exploring further by themselves as there are countless possibilities and opportunities in the Mainland.

The Foundation was founded in 1995, to celebrate the return of Hong Kong to its motherland. In the 20 years since its establishment, Hong Kong has thrived. Let’s treasure what we have achieved and endeavor to make our city, our country and our world a better place for everyone. Mutual trust, your unflinching support and our concerted effort is vital to make our wish come true!

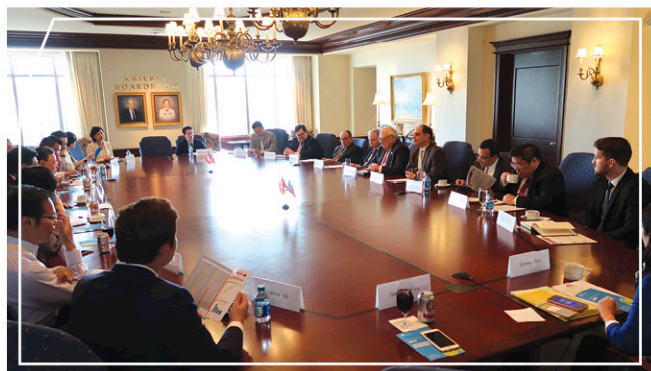

2017 China-U.S. Journalists Exchange

In an effort to enhance the understanding of China and Hong Kong by the American media, since 1996 the Foundation invited six to eight American journalists each year to visit the Mainland China and Hong Kong. The Foundation sponsored and organized their trip. With the support of the Ministry of Foreign Affairs of the PRC, the program enables the journalists to meet with senior government officials in Beijing and local municipal officials in one of the second or third tier cities in China. The Foundation also organizes meetings with key industry and business players, academic and research institutions and media practitioners to broaden the participants' network other than providing them an overview of the cities they visited. This year, the Foundation, in association with the All-China Journalists Association (ACJA) and the East-West Center, organized the Eighth China-U.S. Journalists Exchange program, as an expansion of the original Hong Kong Journalism Fellows program by adding the visit of the Chinese journalists to the U.S. The theme of this year's program is "Bridging the Gaps in Understanding between China and the United States".

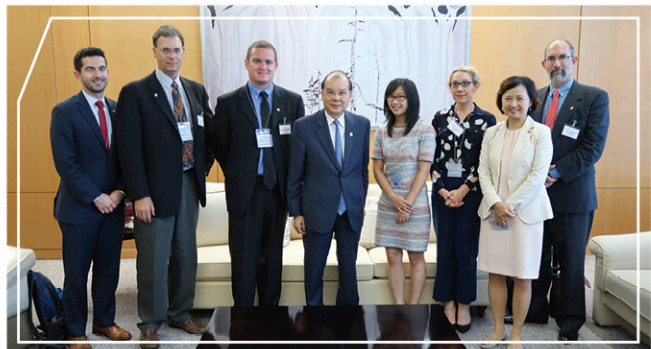

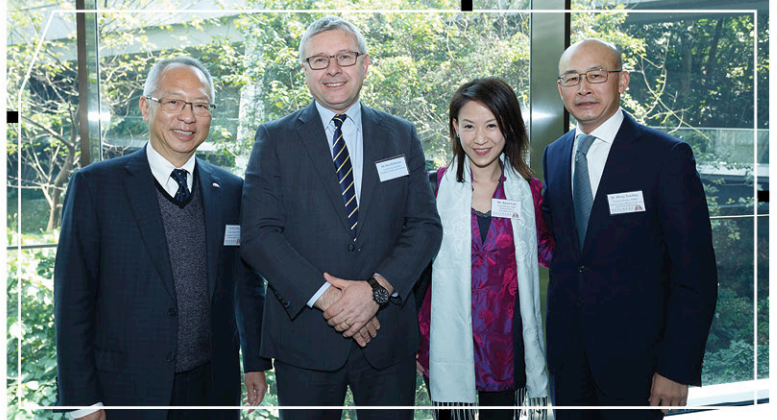

SUSTAINABLE DEVELOPMENT OF HONG KONG

With globalization, rapid change and worldwide competition, we cannot be complacent regarding the current state of affairs. The Foundation, in collaboration with renowned research institutes, conducts studies on the competitiveness of urban cities in China as well as bench marking world cities in the pursuit of excellence. We also recognize the importance of Hong Kong's youth development and the cultivation of a green environment and corporate social responsibility for the betterment and sustainable development of Hong Kong

2017 China Urban Competitiveness Report

The press conference of 2017 China Urban Competitiveness Report (Hong Kong) was held in Hong Kong on 26 June 2016. It was organized by the Better Hong Kong Foundation and co-organized by Center for City and Competitiveness of the Chinese Academy of Social Sciences and Hong Kong Institute of Asia-Pacific Studies of the Chinese University of Hong Kong. Led by Prof. Ni Pengfei of the Chinese Academy of Social Sciences, the theme of the 2017 Report is "Housing Price System: The Leverage and Trap of China in Transformation", identifying the new property price system and revealing the new urban cluster pattern in the process of economic structural transformation in China. The press conference was chaired by the Foundation's Executive Director Ms. Karen Tang where Prof. Ni gave a presentation on the report and further explained the overall competitiveness of Hong Kong and Prof. Shen Jianfa from the Chinese University of Hong Kong commented on the findings about Hong Kong.

According to the Comprehensive Economic Competitiveness Index in 2016, the top ten cities are Shenzhen, Hong Kong, Shanghai, Taipei,

Guangzhou, Tianjin, Beijing, Macao, Suzhou and Wuhan. Hong Kong is ranked second in the Comprehensive Economic Competitiveness Index. Although potential markets have been located for the traditional industries where Hong Kong enjoys clear advantages, Hong Kong needs to develop new sources of growth by promoting new industries driven by innovation and hi-tech, facilitating the diversification and upgrading of industrial activities, and strengthening the foreign trade relations. Hong Kong

tops the Liveability Competitiveness Index and Sustainable Competitiveness Index, and needs to continue the progress of knowledge-based city development. Although Hong Kong is still a leader in these competitiveness indices, the city must be prepared in the context of the new global economy. Hong Kong should carry out economic restructuring and build itself into a new-type global city in order to adapt to the new environment and grasp new opportunities.

Before the press conference, the Foundation's Executive Committee Chairman Mr. Ronnie Chan chaired a luncheon discussion where members of the Foundation and guests exchanged and shared their views on the report. Noting the key suggestion of the report on Hong Kong's competitiveness, the Foundation's members and guests focused their discussions on the importance of innovation to strengthen and sustain the future development of Hong Kong. Invited guests including Mrs. Helen Chan, Government Economist, Mr. David Wong, Chairman of Business and Professionals Federation of Hong Kong and Prof. Anthony Yeh, Chair Professor of Department of Urban Planning and Design of the University of Hong Kong, also shared their views at the luncheon discussion.

The 11th Hong Kong Cup Diplomatic Knowledge Contest

Since 2007, the Foundation has jointly organized the Hong Kong Cup Diplomatic Knowledge Contest with the Office of the Commissioner of the Ministry of Foreign Affairs of the PRC in the HKSAR (Commissioner's Office) and the Education Bureau of the HKSAR Government. The contest aimed to raise students' interest in international affairs and knowledge of the nation's foreign policy. With the theme

of "Hand in Hand with Diplomacy in Our Journey to the 20th Anniversary", the 11th Hong Kong Cup Diplomatic Knowledge Competition was also one of the events in celebration of the 20th anniversary of the HKSAR establishment. More than 13,000 students from 96 primary and secondary schools enrolled in this year's contest which set the highest record since the launch of the contest.
