He founded and chairs China Heritage Fund, is a co-founding director of The Forbidden City Cultural Heritage Conservation Foundation, Beijing, and is an Advisor and former Vice President of China Development Research Foundation in Beijing. Internationally, Mr. Chan is Co-Chair of Asia Society and Chairman of its Hong Kong Center, a Director of the Board of Peter G. Peterson Institute for International Economics and a member of Council on Foreign Relations, National Committee on United States-China Relations, and Committee of 100. He is Founding Chairman Emeritus of Asia Business Council, a former Chairman of Hong Kong-United States Business Council, and a former member of the governing board of World Economic Forum. He serves or has served on the governing or advisory bodies of several think tanks and universities, including Tsinghua University, Fudan University, University of Southern California, East-West Center, Pacific Council on International Policy, Eisenhower Fellowships, and The Maureen and Mike Mansfield Foundation.
