Mr. Ronnie C Chan is Chairman of Hang Lung Group Ltd and its subsidiary Hang Lung Properties Ltd, both publicly listed in Hong Kong. Founded in Hong Kong in 1960, the Group expanded into mainland China in 1992, developing, owning and managing world-class commercial complexes in key tier one and tier two cities. Mr. Chan co-founded the privately held Morningside group. He is Chairman of the Executive Committees of One Country Two Systems Research Institute and of The Better Hong Kong Foundation. He founded and chairs the China Heritage Fund, is a co-founding Director of The Forbidden City Cultural Heritage Conservation Foundation, Beijing, and is former Vice President and former Advisor of the China Development Research Foundation in Beijing. He is founding Chairman of the Centre for Asian Philanthropy and Society, and founding Chairman Emeritus of Asia Business Council. He is also former Chairman of the Hong Kong-United States Business Council. Mr. Chan is a Fellow of the American Academy of Arts and Sciences, Co-Chair of Asia Society and Chairman of its Hong Kong Center, and a member of the Council on Foreign Relations, the National Committee on United States-China Relations, and Committee of 100. He serves or has served on the governing or advisory bodies of several think tanks and universities, including Peterson Institute for International Economics, World Economic Forum, East-West Center, Pacific Council on International Policy, Eisenhower Fellowships, The Maureen and Mike Mansfield Foundation, University of Southern California, Indian School of Business, Yale University, Tsinghua University, and Fudan University.

Mr. Andrew Yao is the Chairman and CEO of Hong Kong Shanghai Alliance Holdings Ltd (formerly known as Van Shung Chong Holdings Ltd) listed on the Main Board of the Hong Kong Stock Exchange since 1994. He also founded iSteelAsia Holdings Ltd listed on the Growth Enterprise Market of the Hong Kong Stock Exchange in 2001. He is Chairman of Hong Kong Shanghai Land Ltd, a company investing in office and commercial property projects in downtown Shanghai. Past projects include Metropark, Central Park Putuo and Central Park Pudong. He graduated from the University of California, Berkeley and the Harvard Graduate School of Business. In December 2012, he was elected to the National People's Congress, becoming one of 36 Hong Kong deputies at the highest organ of state power in China. Mr. Yao serves as Vice Chairman of Shanghai Federation of Industry and Commerce, Chairman of Hong Kong-Shanghai Economic Development Association and Shanghai Hong Kong Association. Board Member of HBS Global Alumni, Founding & Honorary Chairman of Hong Kong -Shanghai Youth Exchange Promotion Association, Board Member of Fudan University, Deputy Chairman of Council of Hong Kong Baptist University, Honorary President of Hong Kong Chamber of Commerce (Shanghai), and Maritime Silk Road Society. He was also the Standing Committee Member of All-China Youth Federation, the Standing Committee Member of China People's Political Consultative Conference of Shanghai (CPPCC), Vice Chairman of Youth Federation of State-owned Enterprises and Shanghai Youth Federation. He was former member of the Central Policy Unit of the HKSAR, former Chairman of the Hong Kong United Youth Association (2007 – 2008), founder of the Young President Organization (YPO) Shanghai Chapter. Mr. Yao was awarded "Young Industrialist Awards of Hong Kong" in 2004 and was awarded Justice of Peace by HKSAR in 2008. In 2010 and 2011, was awarded "Annual Contribution Award of Shanghai Youth Federation". In 2016, the HKSAR Government, awarded him the Bronze Bauhinia Star (BBS) for his contribution to the promotion of youth development in Hong Kong.



Mr. Thomas Woo has been serving in catering industry in Hong Kong for more than 40 years. He is the governing director of Hsin Kuang Restaurant (Holdings) Ltd which is operating 40 Chinese chained restaurants in Hong Kong, the Mainland China, Canada and the United States. Ms. Woo is one of the important role players

in catering industry and he is also leading over 200,000 members of Hong Kong catering industry in right track. In 2012, Mr. Woo was invited by the United Nations to organize a celebratory luncheon for the Public Service Day Celebration and Awards Ceremony at the UN Headquarters in New York. Subsequently, Mr. Woo cooperated with the Chinese Cuisine Training Institute of Hong Kong and successfully organized an Imperial Banquet (Manchu-Han Banquet) for charity purpose. During his travelling in 2013, he met with Mr. Zhan Lian, Honorable Chairman of Kuomingtang, Mr. Lung Bin Hau, Mayor of Taipei City and Mr. Jason Hu, Mayor of Taichung City to discuss the scheme of Chinese cuisine festival over the four cities in future. Since 1967, Mr. Woo has devoted himself to social services, charitable events and educational affairs. He is also a former director of Sik Sik Yuen Wong Tai Sin Temple, which is one of the largest charitable organizations managing 16 primary and secondary schools and private hospitals in Hong Kong. Since 1997, Mr. Woo has dedicated himself to the Lifeline Express Hong Kong Foundation which cures more than 200,000 blind cataract patients from remote areas of the Mainland China by providing free surgical operations by means of four mobile hospital trains called the Lifeline Express. In 2000, he was awarded the Bronze Bauhinia Star Medal by the HKSAR Government.



Ms. Winnie Ng, outstanding businesswoman in Hong Kong, is Director of Kowloon Motor Bus Company Ltd, Founder & Deputy Chairman of Roadshow Holdings Ltd, and has been Council Member of the Better Hong

Kong Foundation since 2006. Kowloon Motor Bus, a prominent company established for over 80 years, is one of the largest bus companies in the world. Ms. Ng, named a "Woman of Excellence", has received numerous awards and recognition: Nobel Laureate Series-Asian Chinese Leadership Award, China Top Ten Outstanding Women Entrepreneurs, Yazhou Zhoukan Young Chinese Entrepreneur Award, one of 60 Meritorious Chinese Entrepreneurs with Achievement and National Contribution, and Mason Fellow of Harvard University. She is well-known for her innovation and creativity in founding the media group RoadShow Holdings Ltd, which business model has been adopted by many companies in Hong Kong, China and over the world. An active supporter of public service, she is Chairperson of Hospital Governing Committee of Prince of Wales Hospital, Member of Town Planning Board, Advisor of Our Hong Kong Foundation, Court Member of Polytechnic University, Member of Vocational Training Council, and Public Relations Committee Member of Community Chest. She was Member of Hong Kong Tourism Board, and Member of Hospital Authority from 2010 to 2016. She holds an MBA from University of Chicago and an MPA from Harvard University.



Mr. Philip Ma was born in Hong Kong and holds a MBA degree from Canada. Sincere is a public listed company in Hong Kong and is the first Chinese owned and operated department store since 1900. Today,

Sincere is a well-known retail brand in Hong Kong which operates six department stores. The focus is on imported ladies wear and men's wear, shoes, accessories and household items. Mr. Ma is active in his community services which cover, Member of the Shanghai Committee of Chinese People's Political Consultative Conference (CPPCC), Member of the Zhongshan, Guangdong CPPCC, Vice-Chairman of the China Chamber of Tourism, Member of the Hong Kong Chief Executive Election Committee and Chairman of the Hong Kong Retail Management Association.

Prior to joining Yue Hwa, Mr. Yu worked at Singapore's sovereign wealth fund, the Government of Singapore Investment Corporation Pte Ltd, where he managed real estate investments in South East Asia and China for the fund from 2007 to 2012.
